



# ENGINE KITS

## Two Year Limited Warranty

**Effective Date:** This warranty is valid for Costex Tractor Parts ("CTP") engine kits purchased on or after January 1, 2019.

**Warranty:** The warranty period is two years from the date of the end user's purchase of an engine kit. During the warranty period, CTP warrants each new replacement part to be free from defect in material or workmanship under normal use and service after proper installation. CTP's obligation under this warranty is limited to the replacement, repair, or refund of parts which are determined by CTP to have been defective within the warranty period.

**Qualifications:** It will be the responsibility of the end user purchasing the engine kit to retain and submit to CTP the original sales receipt from the CTP authorized dealer together with a copy of the properly completed CTP warranty claim form. The warranty only covers the original end user of the engine kit and applies only to engine kits purchased from a CTP authorized dealer. A warranty registration form/card is included inside each engine kit. The warranty registration form is provided by CTP at the time of purchase. Proper submittal of the registration form with CTP helps ensure the accuracy of the warranty period, while failure to do so may limit this warranty.

**Warranty Claim Requirements:** Failure to comply with the requirements below will void your warranty.

- The original purchaser of the engine kit must continue to own the equipment on which the defective part(s) were installed.
- Written records of OEM specified oil & filter changes, scheduled maintenance, and service adjustments carried out by a qualified technician must be kept. The engine run time must be less than 3,600 hours. Copies of these records must be accompanied when submitting a warranty claim.
- A warranty claim must be submitted within thirty (30) calendar days of part failure.
- The original purchaser must provide a copy of the original sales receipt from the CTP authorized dealer and a copy of the submitted CTP Warranty Registration Card.
- The original purchaser seeking a warranty claim must return the damaged parts (if requested by CTP) only after receiving an RGA (returned goods approval) from the claims department. Parts returned are to be pre-paid freight by the claimant. CTP is not responsible for freight charges on returned parts.

**Note:** Items returned to CTP under warranty claim become the property of CTP.

**CTP's Responsibilities:** If a defect in material or manufacturing is found in a CTP engine part (at CTP's sole determination) during the two-year warranty period, CTP will cover the cost of the repair labor and/or supply the replacement part(s), as may be applicable, to return the engine to its operating condition.

**Specifically, CTP will, at its sole election:**

- Provide new CTP brand replacement parts needed to correct the defect. Note: If the CTP brand is not available or if the user opts not to use the CTP brand, a credit of equal value will be issued.
- Provide reasonable or customary labor credit needed to repair the defect, including labor for the removal and installation of the engine, if deemed necessary to make the repair.
- Credit the cost of lubricating oil, filters, coolant and consumables necessary to complete the engine repair.

**What is Not Covered:**

- Loss of time, inconvenience, loss of use or other incidental or consequential damages.
- Fluids, or additional parts required that are not engine related.
- Travel to and from the location of the repair facility of the equipment.
- Hotel, lodging, meals or expenses incurred during the repair of the engine.

In addition, CTP is not responsible for failures due to:

- Improper assembly, installation, alteration or damage to parts during assembly.
- Damage caused by the use of a coolant or coolant mixture not in accordance with the OEM specifications.
- Improper application; use of part in a manner not specified by the OEM.
- Abuse, neglect, and/or improper repair, including the assembly of the engine in contaminated environments.
- A claimant's delay in correcting or rectifying a condition that would have prevented the failure.
- Neglected maintenance, repairs or adjustments deemed necessary that would have prevented the failure.
- Attachments, and accessories added or modified to the equipment that are not OEM sanctioned.
- Modifications for performance gains other than the OEM recommended settings.

This warranty does not apply to any product that has been modified or altered to fit, misused, subjected to excessive operating conditions, malfunctions due to contamination, poor oil management, improper oil viscosity or foreign particles contaminating the oil a result of poor oil management. The product warranty does not deem the loss of oil pressure/ low oil pressure or a high temperature condition as a reason for extensive engine repairs or complete disassembly of the engine. This is based on the equipment having the proper warning lights or gauges, to warn the operator of low oil pressure, or over-temperature prior to the engine incurring any damage. If the operator chooses to ignore these gauges or warning lights, or the system of gauges or warning lights are not in working condition, this constitutes negligence on the operator's part. CTP cannot be held responsible for operator negligence that results in any engine damage.

**Additional Important Information:** THIS LIMITED WARRANTY DOES NOT COVER LABOR COSTS OR INCIDENTAL, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES SUCH AS, BUT NOT LIMITED TO, PHYSICAL INJURIES OR PROPERTY DAMAGE, LOSS OF TIME, LOSS OF USE OF THE VEHICLE, INCONVENIENCE, RENTAL VEHICLE CHARGES, TOWING CHARGES OR ACCOMMODATIONS RESULTING FROM A DEFECT IN OR FAILURE OF THE PART.

This limited warranty represents the exclusive remedy for any product defect or failure and the total liability of CTP and its subsidiaries and affiliates for any part it warrants. CTP MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, CONDITION OF ANY KIND OR FITNESS FOR A PARTICULAR PURPOSE. Some states and provinces do not allow disclaimers of implied warranties. Therefore, all implied warranties that may apply to your part are limited to the duration of this written warranty. Some states and provinces also do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental, special or consequential damages, so the above information may not apply to you. This warranty gives you specific rights, and you may have other rights which vary from state to state. CTP does not authorize any person to vary the terms, conditions or exclusions of this warranty. If any provision of the warranty should become invalid or unenforceable because of any laws, the remaining terms and provisions of the warranty shall remain in full force and effect. To the extent allowed under local law, the remedies provided in this **Limited Warranty Policy** are the customer's sole and exclusive remedies.
